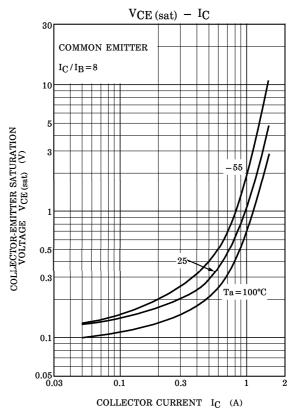




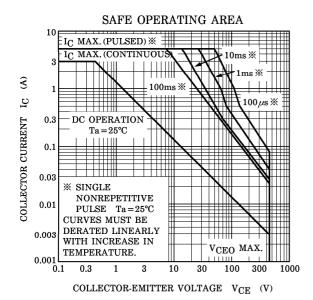
COLLECTOR CURRENT I_C (A)
