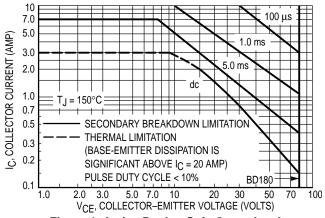

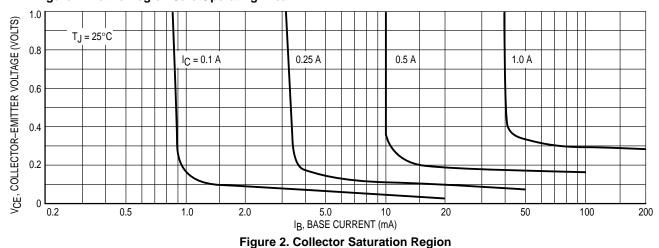

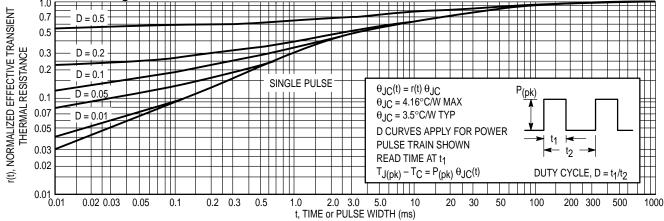
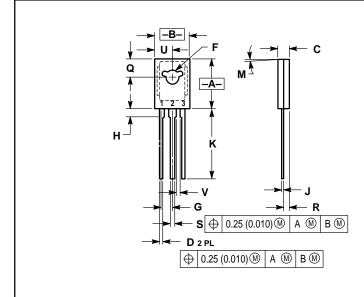


Figure 5. Thermal Response
