A POINT OF VIEW

Excerpt from the Yale Baccalaureate Address given by President Kingman Brewster, Jr., on 9 June.

"Hell no, I won't go" is a slogan which can equally well shelter the coward, the traitor, the selfish, as well as provide the banner for the courageous, the conscientious, and the selfless.

Yet such ambiguous negativism is almost forced on some of the most highly motivated among you by the wretchedness of a law which leaves no room for selective conscientious objection during a war in which many in good conscience cannot serve. . . .

I am not worried about those who find their clear duty in military service. I am not worried about those of you who follow their conscience all the way to jail. To me the tragedy is that there seems to be no way for the rest of you to affirm your willingness to serve and even sacrifice in a just cause.

For the selective objector there seems to be no way to demonstrate—even symbolically—that the rejection of "my country right or wrong" is in fact superseded by "humanity, right or wrong."

How do you demonstrate this positively? How do you put your name and honor on the line in a way which convincingly differentiates you from the coward, the malingerer, the totalitarian fifth columnist?

Most selective objectors, I believe, would fight in any war which commanded the support of a preponderant majority of the members of the United Nations. There is a real sense of the difference between a Korea and a Vietnam.

Even if it cannot be done operationally, an expressed willingness to serve in a United Nations Reserve would dramatize symbolically the recognition that to keep the peace does require an authority which transcends nations. It would offer a chance to affirm that the call of such an authority would command the sacrificial service of many of those who are left with only the ambiguous, negative stance of protest, resistance, refusal. . . .
