in Hanford, Washington. Speakers addressed the geology of the Hanford site as well as the process of how scientific information is used—or misused—by government decision-makers.

Other sessions included those on Canada's water resources, health care on the Pacific rim, the Canadian–U.S. Pacific Salmon Treaty, health problems and radiation, ecology of Arctic fishes, and energy conservation in the Arctic.

A highlight of the meeting was a lunchtime public lecture by Paul MacCready, whose giant pterosaur is currently starring in the Smithsonian Institution's new film "On the Wing." MacCready described his many exciting "flights of fancy" and showed slides of the pterosaur and his earlier "Gossamer Condor," "Gossamer Albatros," "Gossamer Penguin," "Solar Challenger," and "Bionic Bat."

At the joint divisional banquet, Pacific Division President and local host of the meeting Geoffrey G. E. Scudder treated the audience to a beautiful look at "Canada's Galapagos: The Queen Charlotte Islands." His lecture summarized evidence for evolution drawn from plant and animal distribution in the Charlottes, especially when compared to the mainland.

In addition to symposia, the meeting included contributed and student papers from a variety of scientific disciplines. Two student papers received special recognition. Maria Emilia Klut of the University of British Columbia (UBC) received the Lawrence M. Klauber Award for Excellence (general) and Patrick A. Lavin of UBC won the Geraldine K. Lindsay Award in the Natural Sciences.
