Transcripts of Discussion Focusing on the Use of Animals in Research Offered

A new transcript entitled Effects of Regulation on the Use of Animals in Biomedical Research is now available through the AAAS Office of Communications. The transcript is from the fourth Media Roundtable held at the National Press Club in Washington, D.C., in July 1986. The panel participants included Barbara Hansen, vice chancellor for graduate studies and research at the University of Maryland; Franklin Loew, dean, Tufts University School of Vet-

erinary Medicine; Charles Mc-Carthy, director, Office for Protection from Research Risks, National Institutes of Health; Dennis Stark, director, Laboratory Animal Research Center and Alternative Research Program, The Rockefeller University; and Richard Crawford, chief staff veterinarian for zoo and exhibition animals, U.S. Department of Agriculture. Gary Ellis, project director, Office of Technology Assessment, moderated the discussion.

This Media Roundtable was the last held as part of the Media Outreach Program which was cosponsored by the AAAS, Scientists' Institute for Public Information, and the Association of American Universities, under a grant from the Andrew W. Mellon Foundation.

Nomination of AAAS Fellows Invited

A Fellow is defined as "a Member whose efforts on behalf of the advancement of science or its applications are scientifically or socially distinguished." Examples or areas in which nominees may have made significant contributions are research; teaching; technology; services to professional societies; administration in academe, industry, government, and other institutions; and communicating and interpreting science to the public

Following their election, new Fellows will receive certificates, and a list of their names will be published in the Proceedings Issue of *Science*.
