AAAS Annual Elections: Preliminary Announcement

The Association's 1989 elections will be held in late August. All members will receive a ballot for election of the president-elect, members of the Board of Directors, and members of the Committee on Nominations. A slate of candidates for section chair-elect, member-at-large of the section committee, and members of the Electorate Nominating Committee will be included on the ballot for each member who is enrolled in one of the 22 electorates corresponding to the AAAS sections. In addition, eight electorates will elect Council delegates.

Candidates for all positions are listed below. Additional names may be placed in nomination for any position by petition submitted to the Executive Officer not later than 17 July. Petitions nominating candidates for president-elect, members of the Board, or members of the Committee on Nominations must bear the signatures of at least 100 members of the Association. Petitions nominating candidates for any electorate or section position must bear the signatures of at least 50 members of the electorate. A petition to place an additional name in nomination for any position must be accompanied by the nominee's curriculum vitae and statement of acceptance of nomination.
