EPA Fellows Program Expanded

As a testament to its success and tenure, AAAS and the U.S. Environmental Protection Agency (EPA) celebrated the 17th anniversary of the AAAS/EPA Environmental Science and Engineering Fellowship program and marked its expansion from a 10-week summer fellowship to a 1-year program.

Former fellows and representatives of the Washington, D.C., environmental policy community gathered at AAAS on 4 June to reflect on the fellowship's history. The event featured Paul Portney, president of Resources for the Future, who addressed the event's theme, "Making History: The Past and Future of Environmental Policy."

North Carolina State University professor Jean Beagle Ristaino, a 1996 Environmental Fellow, said she received a phone call from a staff member of the U.S. House of Representatives Agriculture Committee as she was preparing her remarks for the anniversary celebration. The staffer wanted to know what questions should be asked during a hearing on methyl bromide—a commonly used soil fumigant that is also an ozone depleting compound.

"This is a perfect example of how my fellowship experience broadened my linkages with others outside the research community," Ristaino said. "I now know that scientists can and should continue to provide relevant information to policy, regulatory, and legislative agencies so policy-makers can make informed science-based decisions." Ristaino's work on methyl bromide has been used by policy-makers and others outside the scientific community to support phasing out the chemical by January 2001.

Peter Preuss, director of the National Center for Environmental Research and Quality Assurance at EPA, which funds the fellowship, says that many of the 170 scientists who have served as fellows are now leading practitioners of environmental science.

"I am always surprised at how much the fellows are able to accomplish in 10 weeks," Preuss said. He added that there is already much interest from the agency about the 10 incoming year-long fellows, particularly for the fresh outlook they bring to issues, as well as their expertise. "The response has been so positive, we may want to expand the program beyond 10 fellows."

offices, and nonprofit organizations to investigate opportunities for her year-long fellowship, which begins 1 September. The Revelle Fellow can serve anywhere in the Washington, D.C., policy community working on domestic or international issues encompassed under the umbrella of "global stewardship." This flexibility to select her own host, Kinzig says, is welcome.

"I am looking for a place where I have access to a cross section of policy issues and can interact with a variety of policymakers, agencies, and organizations," Kinzig said. "I'd like to put myself where I can get the most comprehensive picture

possible, and I would like to use the fellowship to pursue something that might otherwise be difficult to obtain."

Kinzig holds a joint postdoctoral research position with Princeton University's Department of Ecology and Evolutionary Biology in the Center for Energy and Environmental Studies, and the Science, Technology, and Environmental Policy Program in the Woodrow Wilson School of Public and International Affairs. She is also the assistant director of the Princeton Environmental Institute. Kinzig received her Ph.D. from Berkeley's interdisciplinary Energy and Resources Group.
