SCIENCE AND THE STATE OF MIND¹

YOUR president's invitation to address the American Science Teachers Association both flattered and intimidated me. An economist who has any inkling of what mathematics, astronomy, physics, chemistry and biology in its numerous branches have accomplished is grateful when representatives of these shining disciplines admit him to their company. But he feels that in their company his proper role is that of listener, not of speaker. Your techniques are far more advanced than his, your results are more securely established, you have and you merit higher prestige both in intellectual circles and with the general public. From you an economist should be able to learn much; whether he can make any return in kind is doubtful.

Yet there is a way of conceiving science that rationalizes, and perhaps justifies, both your invitation to speak and my acceptance. Despite the bewildering

A physicist may not understand the technical papers of a physiologist, and vice versa; but the two workers approach their problems in the same spirit. Both workers seek to unite accurate observation of phenomena with systematic analysis of relations; neither expects that his results will be accepted unless they are confirmed by competent investigators who repeat his experiments and check his reasoning; each realizes that what he observes and what he thinks is influenced by a personal equation, but each tries to keep this factor from warping his conclusions more than is inevitable.

In short, we cherish the ideal that all scientific men are single-minded in their search for truth. We expect them to avoid wishful thinking; that is, they must not alter their findings to suit the non-scientific beliefs or longings or dislikes of others or themselves. All of them are supposedly ready to expose

Sinnott and Dunn's PRINCIPLES OF GENETICS

New third edition

By EDMUND W. SINNOTT and L. C. DUNN, Columbia University. McGraw-Hill Publications in the Botanical Sciences. 410 pages, 6 x 9. \$3.50

For the past thirteen years this eminently successful textbook has maintained its position as a leader in the field, and may well be regarded as a classic. Over one hundred colleges and universities adopted the second edition. Now the authors have thoroughly revised the book to bring it abreast of current developments in genetics, and have added a large amount of new material, new problems, new illustrations, etc. Contributions to genetics from studies of salivary gland chromosomes have been included up to September, 1938. An entirely new chapter on cytoplasmic inheritance has been added. The treatment of genetics and evolution has been completely rewritten to include new methods and materials.

Pearse's ANIMAL ECOLOGY

New second edition

By A. S. PEARSE, Duke University. McGraw-Hill Publications in the Zoological Sciences. In press-Ready in January

This pioneer text, a general survey of the science of the responses of animal organisms to the factors of their environment, discusses physical, chemical, and biological factors; succession; the various groups of animals; relations of animals to plants and to color; the economic relations of ecology; etc. In the new second edition Professor Pearse has rewritten the entire book to bring it up to date and has presented the material in a more logical sequence. The book is more comprehensive and thorough than the earlier edition, and includes new materials on climate, communities, succession, populations, etc. The chapters on problems of ecology and teaching of ecology are new. One hundred thirty-two illustrations, many of them original, have been added.

Emmons, Thiel, Stauffer and Allison's GEOLOGY. Principles and Processes

New second edition

By WILLIAM H. EMMONS, GEORGE A. THIEL, CLINTON R. STAUFFER, University of Minnesota, and IRA S. ALLISON, Oregon State College. 447 pages, 6 x 9. \$3.75

For the past six years teachers have regarded this text as one admirably suited to the elementary student both because of its easily comprehensible and attractive style and because of its thorough, balanced treatment of all the essential topics. In its second edition, *Geology* has been thoroughly revised and completely reset. Many important changes and improvements have been made in arrangement and treatment, and the text is now better suited to the usual first course in Physical Geology. A chapter on sediments and realms of sedimentation has been added. The chapter on diastrophism has been enlarged to include the structures of rocks, which in the first edition was treated in a separate chapter. The final chapter, on earth history, which was of limited value in most courses, has been omitted. The selection of illustrations has been improved.


