"The Medfly in California: The Threat, Defense Strategies, and Public Policy" is sponsored by the western section of the American Society for Horticultural Science. Participants represent the major protagonists in the dispute, notably the state and federal departments of agriculture. Speakers will review the problem and attempted solutions, and will assess effects of the medfly extermination campaign on public health, horticultural crops, and the environment.

The AAAS national office is conducting two symposia at the meeting. "Computers and Science Teaching: Perspectives in the Life Sciences' will report on the use of videodiscs in teaching biology, on testing learning by use of computers, and on personal computers as aids in learning science. A session on "Access to Science for Women and Minorities" will highlight successful programs which have prospered in the Pacific region, such as MESA, EQUALS, the Bay Area Math/Science Network, Math Science Interchange, the Math Without Fear Program at San Francisco State University, and the Minority Women in Science Network.

"Science, Deviance, and Society" will examine areas of aberrant behavior in the science professions. Speakers will look at scientific frauds; science misrepresentations, or "white coat" crime; compliance and noncompliance with rules regarding research on human subjects; policing scientific research; and the sociological and ideological bases of deviant behavior in science.

Other symposia topics include the Biogeography and Evolution of Oaks, Amphibian Physiology, Factors in Biotic Diversity: A Paleontologic Perspective, and Health and Social Sciences: Implications for Public Policy. Contributed paper sessions are scheduled in meteorology, ecology, botany, horticultural sciences, psychology, plant physiology, biology, and geology. Field trips are planned to Santa Cruz Island, local orchid nurseries, Ransom Seed Laboratory, Santa Barbara wineries, and sites of interest to horticultural science. Social events include a welcoming party, wine and cheese tasting, and the Division banquet, with a presidential address by Robert I. Bowman, San Francisco State University, on a centennial view of Darwin's finches.

Short courses on several scientific topics will be offered during the meeting, with an option for continuing education credit through San Francisco State University. Topics include industrial organic chemistry, personal computers in learning science, origin and early evolution of life, plate tectonics, and ecology of terrestrial microcommunities.
